BIOSECURITY

All horses coming on to the grounds must provide proof of Equine Influenza and EHV vaccinations (vaccinations must be administered within the last 6 months, +21 days, but not within 7 days of arrival to the grounds). Horses exhibiting any signs of illness will not be permitted on to the grounds. Competitors are required to notify the tournament office at the first sign of illness or elevated temperature.

Horses missing valid vaccinations will NOT be permitted on the grounds, and entries are NOT eligible for a refund of fees. NO EXCEPTIONS. Proof of vaccination must be signed by a veterinarian and be on a veterinary letterhead.

All horses being brought on to the grounds must not have been in contact with any horses exhibiting any signs of illness within the last 14 days prior to the tournament. Horses are not permitted to come onto the grounds if they are stabled at a facility where any horses have been at a venue with a confirmed case of EHV (neurologic or non-neurologic) or any other transmittable illness/disease within the last 21 days prior to the tournament. Please avoid direct and/or indirect contact between horses, especially nose-to-nose contact and the use of common feed/water buckets.

The Varena Equestrian Team will closely monitor any developments regarding potential biosecurity issues for both horses and humans and will change the procedures and requirements for horses entering the grounds as needed. Changes may be made with little/no warning.

HORSE WELFARE

The abuse or inhumane treatment of a horse by an exhibitor, trainer, or other person at an Alberta Equestrian Federation sanctioned competition shall not be tolerated under any circumstances. The competition organizing committee has the right to bar such violators from further participation in the competition if necessary.

The Picco Horse Show is sanctioned by the Alberta Equestrian Federation.

1. AEF supports adherence to humane treatment of horses in all activities under its jurisdiction.
2. AEF is committed to:
 - a. Upholding the welfare of the horse, regardless of monetary value, as a primary consideration in all activities.
 - b. Requiring that horses be treated with kindness, respect, and the compassion that they deserve, and that they never be subjected to mistreatment.
 - c. Ensuring that owners, trainers and exhibitors and their guests exercise appropriate care and responsibility in the handling, treatment, and transportation of their horses, as well as horses placed in their care for any purpose.
 - d. Providing for the continuous wellbeing of the horse by encouraging routine inspection and consultation with healthcare professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort, and safety.
 - e. Continuing to support scientific studies on equine health and welfare.
 - f. Requiring owners, trainers, and exhibitors to know and follow their sanctioning organizations rules, and to work within industry regulations in all equestrian competitions.
 - g. Reviewing, revising, and developing competition rules and regulations that protect the welfare of the horse.



3. In determining whether conduct or treatment is cruel, abusive, or inhumane, the standard to be applied will be the conduct or treatment expected of a reasonable person who is informed and experienced in equine training and exhibition procedures.
4. Individuals who interact with horses must also adhere to AEF's policies as they relate to horse welfare.

Every class offered herein is covered by the rules and specifications of the current rules of the AEF and will be held and judged in accordance with the AEF Rule Book.

OFFICE HOURS

The tournament office is open from 10:00am – 4:00pm on non-tournament days, and from 30 minutes before the start of the first competition until 30 minutes after the end of the last competition on tournament days. The Tournament Office is located on the left-hand side of the main entrance to the Varena Equestrian Indoor Arena Building. Signage will be provided during tournaments.

VEHICLES & PARKING

There will be designated parking areas on the grounds for competitors' vehicles and trailers. Please do NOT park in front of any barn doors or block alley ways. Vehicles and trailers will be towed and/or fines levied if parked outside of the designated areas. Clear signage will be provided designating parking areas.

On-site RV parking and camping will be permitted during tournaments. Varena Equestrian does not offer full service or power hookups for RV's. Athlete's wishing to bring an RV or live-in quarters trailer, must have it registered with the Tournament Office to receive a parking pass at a cost of \$20.00 per day or \$100.00 for the tournament week.

Minors who do not have a valid drivers license that allows them to operate a motorized vehicle in the province in which they reside will not be permitted to operated a motorized vehicle of any kind, including but not limited to, golf carts, scooters, motorbikes, or farm utility vehicles while on the tournament grounds. Minors that have a valid temporary license may operate the above described motorized vehicles while under the supervision of an adult with a valid driver's license. Violations of this rule will be cause for sanctions against the parent/guardian and/or trainer who is responsible for the child committing the offense. An unlicensed minor caught driving a motorized vehicle on the Varena Equestrian grounds will be issued a fine of \$500.00 which will be added to their horse account.

There is a 20km per hour speed limit on the Varena Equestrian grounds. Failure to abide may result in fines or expulsion from the grounds. **HORSES HAVE THE RIGHT OF WAY AT ALL TIMES.**

SMOKING/VAPING/CANNABIS

There is no smoking or vaping allowed in any Varena Equestrian building and within 10 feet of any entrance thereof. Any person caught smoking in any building or outside an entrance will be assessed a fine of \$250.00, applied to the horses account. Further offenses may result in being asked to leave the tournament grounds and a forfeiture of tournament fees paid. The use of Cannabis (including but not limited to smoking) is **STRICTLY PROHIBITED** on the Varena Equestrian grounds. Violators may be fined and asked to leave the property.



PETS

Pets must be on a leash **AT ALL TIMES** while on the Varena Equestrian grounds. Unleashed pets will be taken by Varena Equestrian staff to a safe location on the property. Release may be obtained after the payment of a \$200.00 fine, applied to the horses account. Further offenses may result in being asked to leave the tournament grounds and forfeiture of fees paid. Acceptance into future tournaments will be at the discretion of the Organizing Committee. Dogs that are aggressive or vicious will be banned from the tournament grounds.

PETS ARE NOT PERMITTED IN THE WARM-UP ARENA OR THE COMPETITION ARENA AT ANY TIME.

TIME SCHEDULES

1. Tentative schedules will be available at the Tournament Office and will be posted on the Varena Equestrian website and Facebook page. Please note that schedules are subject to change daily during the tournaments.
2. Tournament Management reserves the right to change the class order, if necessary, after the close of entries. It is the responsibility of the exhibitor to determine when his/her class will be judged.
3. Tournament Management reserves the right to cancel or combine any class that is not filled to satisfaction. Exhibitors will be notified as soon as possible after the close of entries should either occur.
4. Set **ORDER OF GO** for competitions requiring orders will be posted the night before for each competition on the Varena Equestrian website.

PRACTICE AREAS & SCHOOLING HOURS

Schooling is only permitted in designated areas and at designated times. The Steward or Organizing Committee reserves the right to limit the number of horses in the warm-up arena and/or holding areas. The Warm-Up Arena will be open for lunging during the morning hack. Jumping will not be permitted during the morning hack. Lunging is NOT permitted in the Competition Arena, or once competitions have commenced.

The Indoor Arena is for private Varena Equestrian client use only and is not available to exhibitors during tournaments.

COMPLETION OF ENTRY FORMS

YOUR RIDER WAIVER MUST BE SIGNED. IF YOU ARE A MINOR, YOUR PARENT OR LEGAL GUARDIAN MUST SIGN. TRAINER SIGNATURES ARE NOT ACCEPTABLE. PERSONS RESPONSIBLE MUST BE OVER THE AGE OF 18 AND ATTENDING THE TOURNAMENT.

Your entry must include the following:

- **PAYMENT:** Please pay via Credit Card (VISA, MC, AMEX), e-transfer (sent to: julie@varenaequestrian.com) or Canadian Cheque made payable to Varena Equestrian. Varena Equestrian DOES NOT keep credit card numbers on file from previous tournaments. Please be sure to include the card number, expiry date, and card holder signature. *All Credit Card transactions will incur a 3.5% processing fee.* Full payment with signature must accompany the entry form. If you are



paying via cheque, a credit card number must be left for any additional charges. A \$60.00 NSF penalty fee will be applied to the horse account for any cheque payment that is returned.

- The horse name on the entry form **MUST** match the horse name on any official documents (including but not limited to; horse passport, and vaccination record). No horse listed as “Entry” will be accepted.
- Proof of your horse’s influenza and EHV vaccinations.
- All Canadian competitors/owners/coaches/persons responsible **MUST** provide proof of their current Provincial membership with their entry form. Riders will not be permitted to compete without proof of their Provincial membership. The competition is required to ensure all competitors, owners, lessee, and person(s) responsible for an entry hold a current AEF membership to ensure each entry is protected by their own individual liability coverage. Exceptions: Out-of-Province competitors are not required to hold AEF membership provided they are members of their respective P/TSO and are in good standing. A parent or guardian are not required to have an AEF membership if signing as the person(s) responsible for an entry that is a minor/junior competitor.

ACCEPTANCE OF ENTRIES

Varena Equestrian is not responsible for confirming the receipt of entry forms. It is your responsibility to contact the Tournament Office via email (varenaequestrian@shaw.ca) to confirm that your entry has been received in full and is legible. Entries must be sent electronically (varenaequestrian@shaw.ca) or dropped off in person. Entries are only considered valid if signed and accompanied with full payment and biosecurity documentation.

Entries will close at 5:00pm MST on the closing date for each tournament. If your entry form is received after 5:00pm MST on the closing date, it will be marked as a late entry and the late entry fee (\$50.00) will be applied. By signing the entry form, competitors/parents/persons responsible are testifying that the entry is eligible for the competitions entered, subsequent determination that such is not the case, will result in elimination and the forfeiture of all fees paid.

When registering for an AEF sanctioned competition, athletes must indicate the name of their coach on the entry form or specify that they are self-coached. Coaches from other countries must be in good standing with their home federation and must declare/have proof of insurance (Article 102).

LATE ENTRIES

Late entries may be accepted after the closing date up to the day before the start of the tournament subject to the following conditions:

- Entry is submitted in full, inclusive of all required numbers, full payment, signatures and valid vaccinations.
- Approval of the Organizing Committee.
- The number of entries already received.
- Payment of the LATE FEE: \$50.00 per late entry.

LATE ENTRIES MUST BE PAID FOR VIA CREDIT CARD OR E-TRANSFER PAYMENT.



SUBSTITUTION OF ENTRIES

Horse substitutions may be submitted to the Tournament Office, prior to the **WEDNESDAY** of each tournament. An entry may be substituted in writing for a fee of \$40.00, provided that the stabling requirement and entry payment is the same. Substitutions done at time of check-in will be subject to an \$80.00 substitution fee.

PROOF OF VACCINATIONS MUST ACCOMPANY THE SUBSTITUTION FOR IT TO BE ACCEPTED AND PROCESSED.

All substitutions are subject to the approval of the Organizing Committee. Payments that have already been processed will NOT be refunded. It is up to the parties involved in the substitution to handle any billing requirements, but a new form of payment may be used to check-out at the end of the tournament.

STABLING & ADDITIONAL STALLS

Stabling is NOT required for Varena Equestrian tournaments. Haul-in entries will be permitted.

Please clearly mark on your entry form with whom you would like to be stabled. Varena Equestrian makes every effort to assign the requested stabling and regrets that any changes made after the tournament closing date may not be able to be accommodated.

Stalls are required to be cleaned daily, and manure deposited in designated areas. Please do not mix other refuse in with the manure.

Under no circumstances may a horse be placed in a stall to which it has not been assigned. Violations of this rule will result in a \$150.00 fine charged to the horse account. Please inform the Tournament Office of any changes to horse placement within your assigned area. Competitors are not permitted to move from their assigned stalls without the permission of the Tournament Office.

CHARGES PER STALL:

- The Picco Horse Show - \$250.00 per stall (full competition)
 - Stabling is available from 2:00pm MST on Wednesday July 22nd, 2026 until 8:00pm MST on Sunday July 26th, 2026.

ALL EARLY ARRIVALS AND LATE DEPARTURES MUST RECEIVE PREAPPROVAL FROM THE ORGANIZING COMMITTEE. Early arrivals and additional days will be subject to a fee of \$65.00 per stall per day.

If you will be arriving after 5:00pm MST please inform the Tournament Office ahead of time, as staff is not available after hours. Stabling includes a 12' x 12' fully matted indoor permanent stall.

Tack Stalls and Day Stalls can be requested but cannot be guaranteed. Priority for stabling will be given to those staying for the entire tournament. Stall arrangements/plaques may not be changed without notification to, and approval by, the Tournament Office. Changing stall arrangements/plaques without notification and approval will result in a \$50.00 fee per stall arrangement/plaque changed that will be charged to the horse account.



WASH BAYS

Both indoor (hot/cold) and outdoor (cold) wash bays will be available. To avoid flooding, please dispose of any manure and debris deposited in the wash bays accordingly.

A \$100.00 fine will be assessed to those who fail to clean up after themselves or leave the hose running when not in use.

LOST & FOUND

The Lost & Found is located within the Tournament Office. Any items that have not been claimed one week after tournament completion will be donated. Please keep a close eye on your belongings. Varena Equestrian is not responsible for any lost or stolen items.

FEED & BEDDING

INITIAL BEDDING IS NOT PROVIDED.

Feed and Bedding must be ordered through the Tournament Office before 11:00am MST for same day delivery. Orders received after 11:00am MST may not be delivered before the next day. There will be a \$25.00 manure removal fee will be added to the horse account if bedding is not purchased through Varena Equestrian.

Feed and Bedding may be ordered originally on your entry form, or via email (varenaequestrian@shaw.ca) or in person through the Tournament Office. Discrepancies in deliveries will not be considered unless brought to the attention of the Tournament Office on the day of the scheduled delivery.

- Bagged Shavings - \$12.50 per bag
- Alfalfa/Grass Mix Hay - \$20.00/Bale
- Grass Hay - \$20.00/Bale

PRICES ARE SUBJECT TO CHANGE, BASED ON SUPPLY CONDITIONS, PRIOR TO EACH EVENT.

CANCELLATION OF ENTRIES

Varena Equestrian will assess charges on cancelled entries as follows:

- **CANCELLING ENTRY BEFORE CLOSING DATE** – 100% of all fees will be refunded.
- **CANCELLING ENTRY AFTER CLOSING DATE AND UP TO:**
 - **(The Picco Horse Show) 4:00PM MST JULY 17TH, 2026** - 100% refund of entry/stall/paramedic/drug fees. The Administration Fee will not be refunded. Varena Equestrian must receive written notice of cancellation and you are responsible for confirming receipt of the cancellation notice with the Tournament Office.



- **CANCELLING ENTRY AFTER THE ABOVE CUT OFFS AND UP TO:**
 - **(The Picco Horse Show) 4:00PM MST JULY 22ND, 2026** - 100% refund of entry/paramedic/drug fee if a Veterinary Scratch letter is provided prior to the start of competition. If a Veterinary Scratch letter is not provided prior to the start of competition ONLY a 50% refund of entry/paramedic/drug fee will be provided. Stall fees will NOT be refunded. The Administration Fee will NOT be refunded. Varena Equestrian must receive written notice of cancellation and you are responsible for confirming receipt of the cancellation notice with the Tournament Office.
- **CANCELLING ENTRY DURING TOURNAMENT** – No refund will be provided of any fees for that tournament. Varena Equestrian must receive written notice of cancellation and you are responsible for confirming receipt of the cancellation notice with the Tournament Office.

HAUL-IN ENTRIES

Haul-in entries are welcome at all Varena Equestrian tournaments and are subject to a \$30.00 per day fee that will be charged to the horse account. Day stalls for haul-in entries are available at a fee of \$65.00 per stall per day, which includes the haul-in fee. Availability of day stalls cannot be guaranteed.

NON-COMPETING ENTRIES

Due to limited stabling, Varena Equestrian will not be accepting non-competing entries, unless they are haul-in entries. Non-competing horses will be subject to a \$40.00 per day or \$160.00 per week fee charged in addition to their haul-in entry fee.

BRIDLE NUMBERS

Bridle numbers MUST be worn by all horses when outside of their stalls.

Bridle numbers will not be distributed by the Tournament Office, unless a specific class type designates. All bridle numbers must be easily legible. Please see the Show Manager if you have any concerns regarding your bridle number. The use of the wrong bridle number, or having no number, may result in disqualification from the competition and/or tournament.

ENTRY FEES & STARTING

1. The entry fee for all competitions offering \$300.00 or less in prize money is \$45.00 + GST per competition. There will be a \$10.00 + GST late fee added for those competitions added after the cut off time.
2. Please see competition details for start fees for competitions offering more than \$300.00 in prize money. Competitions offering over \$300.00 in prize money started after the cut off time will be charged DOUBLE the start fee.
3. Ticketed schooling and/or clear rounds (when offered) will be \$35.00 + GST per round and must be purchased through the Tournament Office. A horse entered strictly in ticket schooling and/or clear round competitions for the duration of the tournament will be charged the Administration Fee (\$90.00) as well as the Medic Fee (\$35.00).
4. Ring nomination fees will **NOT** be charged at Varena Equestrian tournaments.



5. You will be automatically entered in the competitions as indicated on your entry form if Varena Equestrian has record of all required memberships, signatures, vaccinations and payments.
6. You may add or withdraw from competitions up until 4:00pm MST the day before the competition. Competitions dropped after this time will not be refunded unless a veterinary note is provided at least two hours prior to the start of competition. Late adds will be subject to a \$10.00 per class late add fee in addition to the class entry fee. Late adds may not be able to be accommodated (competition dependent).
7. The horse may only be started ONCE in each competition (i.e. the Trainer and the Student cannot ride the same horse in the same competition). The Organizing Committee reserves the right to limit the number of horses a Rider can compete per competition, the number of horses in a competition, or the number of horses in a tournament/tournament series.
8. There will be no presentations after the completion of Clear Round competitions. The course will be one round over a minimum of 8 numbered jumps and may include at least one double.
9. Hors Concours rounds will be permitted under the rules of Equine Canada and at the discretion of the Judge and Organizing Committee.
10. All competitors must hold a provincial governing body membership (i.e. Alberta Equestrian Federation) to compete.
11. The Medical Fee covers the cost of the Medical Aid on site. The fee does not cover personal expenses incurred by the injured party in the event of an injury or transportation by ambulance.
12. Any horse entered in any class at a competition may be selected for equine medication control testing while at the event location.

SECOND RIDER

If you would like a second person to ride your horse, please ensure that the Second Rider has completed and signed a RIDER WAIVER and has provided all required memberships prior to being declared for a competition. Riders who have not submitted the RIDER WAIVER will have their results disqualified, any prize moneys won revoked, and permission to ride in future competitions will be at the discretion of the Organizing Committee.

Rider changes CANNOT be made at the ring. All rider changes MUST be made in person or in writing through the Tournament Office.

TOURNAMENT AREA CONDUCT

1. No persons other than the Officials or tournament staff on duty may enter the Competition Arena without the permission of the Tournament Manager or the Organizing Committee.
2. Those who enter the Competition Arena for any reason must be neat and suitably attired. Tucked in, collard polo shirts may be worn along with light colored breeches in the Competition Arena for ticketed rounds and/or clear rounds, as well as for regular jumper classes. Hunt Coats/Show Jackets are mandatory for Classic Competitions and the Grand Prix unless made optional by the Organizing Committee. Half chaps with paddock boots will be permitted in the Competition Arena but should match and be clean and presented in a manner that is respectful to the sport. Half chaps and paddock boots/tall riding boots must be black or brown. Formal attire, including a Hunt Coat/Show Jacket and faun breeches is required for Equitation Divisions.
3. **Saluting Protocol:** All competitors are expected to salute the Judge prior to the commencement of their round. The judge will be located within the Judge's Booth on the south side of the Competition Arena. Should you require clarification or direction regarding the saluting procedure, please discuss with the in-gate personnel.



4. The Organizing Committee may determine to pre-load or not pre-load at any point during the competition. Please stay alert to the in-gate personnel for instruction.
5. Competitors are only allowed in the Competition Arena when competing or when the course is clearly marked "OPEN".
6. The Organizing Committee and/or Officials reserve the right to limit the number of horses permitted in the Warm-up Arena at any time during the tournament.
7. Exhibitors are responsible for reporting all entries to the Tournament Office prior to each respective class being called. It is the responsibility of the exhibitor to determine when their class will be judged. **A gate hold will prevail as a courtesy only and will be at the discretion of the Organizing Committee.**
8. No Judge shall be approached regarding any decision during the time he/she is judging or is about to judge. Penalty will be disqualification from the show in its entirety.
9. Exhibitors **MUST** obey arena OPEN/CLOSED signs at the in-gates.
10. You must be on foot when leading a horse.
11. Turn-out paddocks are NOT provided. Horses are not to be turned loose.

PRESENTATIONS

1. All competitors must be mounted when entering the Competition Arena for presentations. Horses may not enter the Competition Arena wearing a cooler unless it is part of the presentation ceremony.
2. Winners of each competition to a maximum of six must be present for presentations. **PLEASE ANTICIPATE IN ADVANCE THE NEED TO RIDE IN FOR YOUR PRESENTATION ON A WELL-MANNERED HORSE.**
3. Your Cavalier's Salute to the Sponsors Representatives and/or the Judge is your way of thanking them. Competitors who do not comply will forfeit their prize money.

PRIZES

ALL PRIZE MONEY WILL BE APPLIED TO THE HORSES ACCOUNT. Any credits after the tournament will be printed on a cheque. The cheque will only be made payable to the Owner and will be paid out once the horse account has been closed.

CLOSE OUT

You are required to pay your tournament bill (Close Out) via cheque, debit or credit card, or e-transfer payment. If you are electing to pay via debit or credit card, please bring the physical card with you at the time you close out. Accounts not closed within 2 days of the end of the tournament will be subject to a \$50.00 outstanding accounts fee, and the payment method used will be that from the entry form.

PROTESTS

Competitors should accept favorable or unfavorable rulings in the spirit of good sportsmanship. If you feel the need to lodge an Official Protest due to a specific ruling, please feel free to bring any concerns to our Tournament Manager for consideration. The Organizing Committee is not bound by the opinions of its staff in these rulings. If you insist on making an Official Protest, it shall be made in writing and delivered to the Tournament Secretary along with a deposit of \$100.00 in cash that will be forfeited should the protest not be sustained.



ORGANIZING COMMITTEE DECISIONS

1. It is important to understand that interpretations of existing rules and regulations and the invoking of additional rules and regulations to cover unforeseen circumstances are the sole responsibility and authority of the Organizing Committee. All Owners, Trainers, Riders, Handlers and Grooms agree to the acceptance of these interpretations and additional rulings by virtue of your signed entry form.
2. It is the objective of the Organizing Committee of Varena Equestrian to run tournaments to the highest possible level of sportsmanship. Judges, Course Designers and Officials have been selected based on their depth of knowledge and experience and their decisions within the competitions are their responsibility. The Varena Equestrian Organizing Committee accepts no responsibility for their decisions.

EXCUSING & DISQUALIFYING

1. Exhibitors are warned that any act of discourtesy or disobedience to the Officials on the part of the Owner, Rider, Handler, or any other person associated with a given entry will disqualify the horse and will result in the forfeiture of entry fees for subsequent classes. Tournament Management reserves the right to remove a Rider, Groom, Handler and/or horse from the tournament without being liable for compensation.
2. Inhumane treatment of any horse on the grounds is forbidden. If a violation occurs, the Organization Committee has the right to disqualify the competitor from the tournament. Such unacceptable treatment will result in forfeiture of all tournament fees paid and prize money earned. Acceptance into future Varena Equestrian tournaments will be at the discretion of the Organizing Committee.
3. In jumping competitions, the judges have the discretions to eliminate a competitor after a sufficient number of penalties have been incurred.
4. In the case of a disqualification of a horse or horses, the winner of the next succeeding prize will take the prize that had been awarded to the disqualified horse(s) and other prizes will be adjusted accordingly.

LIABILITY

All Owners and Competitors are personally responsible for damages to third persons caused by themselves, their employees, their agents, and their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian sport. Neither the Varena Equestrian Tournaments nor the Organizing Committee or the owners of Varena Equestrian, nor any of its staff or agents shall be in any way liable for any accident, injury, damage, loss or for any other matter that may happen, from any cause or circumstance whatsoever, to exhibitors, competitors or members of their family or their agents or to anyone on the tournament grounds or to any animal or article exhibited or to any property brought on the tournament grounds, or for any other loss, claim, matter, circumstance, or event whatsoever in connection with or arising out of or attributable to the tournament or any journey to or from the tournament.

It is to be understood and agreed that under no circumstances shall Varena Equestrian, its owners, agents, employees, or family be liable for any loss, damages, claims or costs occasioned or suffered by any exhibitor, competitor, member of their family or their agents directly or indirectly, howsoever arising, including without

limitation, losses, damages, claims or costs as a result of Varena Equestrian, its owners, agents or employees negligence, and you agree to indemnify and save harmless Varena Equestrian, its owners, agents and employees from and against any and all liability arising out of such loss, damages, claims or costs.



CODE OF CONDUCT

The following offenses are considered grounds for disqualification by the Organizing Committee:

- Unauthorized use of Varena Equestrian materials (bedding & feed), equipment or machinery will result in disqualification of those involved. In addition, willful damage of property as well as what the Organizing Committee considers to be unseemly or unsportsmanlike conduct, will cause the individuals involved to be disqualified. There will be no appeals on these types of Organizing Committee decisions. Varena Equestrian is committed to the highest standards of behavior and sport anticipating from its athletes and their associates similarly high standards.
- Safety and Code of Conduct are top priorities for Varena Equestrian guests, athletes, and staff. Varena Equestrian's policy on Cannabis use is as follows: the use of Cannabis (including but not

limited to smoking) is strictly prohibited on the Varena Equestrian grounds. Athletes are required and expected to adhere to the Equestrian Canada anti-doping regulations. Any group/individual found to be in violation of this rule may be fined and/or asked to leave Varena Equestrian property.

All the people of Varena Equestrian, our professional staff, officials, technicians, sponsors, media people, and volunteers are dedicated to you and will do everything possible to make these the best competitions. By entering the Tournament, you are accepting all the rules and regulations, including the Code of Conduct. The Equestrian Canada Code of Conduct and Ethics will be upheld at all Varena Equestrian hosted events.

PRIZE MONEY BREAKDOWN

1. Ribbons will be awarded to sixth place in all classes unless otherwise specified.
2. Ribbons will not be awarded for Ticketed Schooling/Clear Round classes.
3. Prize money will be divided as follows unless otherwise specified:
 - i. First – will receive 25% of the prize money awarded for the class.
 - ii. Second – will receive 20% of the prize money awarded for the class.
 - iii. Third – will receive 15% of the prize money awarded for the class.
 - iv. Fourth – will receive 12% of the prize money awarded for the class.
 - v. Fifth – will receive 10% of the prize money awarded for the class.
 - vi. Sixth – will receive 8% of the prize money awarded for the class.
 - vii. Seventh – will receive 5% of the prize money awarded for the class.
 - viii. Eighth – will receive 5% of the prize money awarded for the class.
4. Points for championships shall be awarded according to the Equestrian Canada Rules.
5. The Championship and Reserve titles shall be awarded to the two horses that have accumulated the most points performing over the courses in the division in which they are being shown. In the case of a tie, the Championship and/or reserve title shall be awarded to the horse that has accumulated the most points in the final competition of the division.
6. A minimum of 5 entries in a division are necessary for division championship prizes to be awarded.

ORDER OF PERFORMANCE

The **Order of Go** will be posted for all Grand Prix's and Mini Grand Prix's. All other competition orders will be assigned via sign-up located at the competition arena in-gate. Sign-ups will be first come first serve. Special or unforeseen circumstances will be dealt with by the Organizing Committee and Officials on a case-by-case basis.



Any competitor that is not ready to enter the Competition Arena when scheduled, will either forfeit their round, or will have to wait until the end of the class and all other scheduled competitors have competed. If the scheduled class end time has been reached and there is not enough time to accommodate a missed Order of Go time, the round will have to be forfeited.

COACHES

When registering for an Alberta Equestrian Federation sanctioned competition, athletes must indicate the name of their coach on the entry form or specify that they are self-coached.

HELMETS

It is mandatory that any person mounted on a horse anywhere on the competition grounds wear approved equestrian head gear secured with a safety harness permanently affixed to the helmet.

PRIVATE PHOTOGRAPHER POLICY

All private photographers wishing to sell or give their photos taken at Varena Equestrian to exhibitors or competitors must apply for Private Photographer Credentials. This policy only applies to professional photographers and does prevent spectators from using their cameras for personal family members. Spectators must also abide by the rules and regulations outlined in the policy below to ensure the safety of all exhibitors and vendors/photographers.

Varena Equestrian Official Photographer Rylee Smolarchuk and Team

Conditions

- Individual Private Photographer Credentials can be purchased for \$500.00. A client list (maximum of five horses) and payment must be received by 5pm on the Monday of each tournament week to gain approval.
- Approved credentials are non-transferable and may not be swapped between representatives.
- Approved photographers may not solicit additional clients beyond the list submitted at the time of approval.
- Photographers must provide proof of insurance to be eligible for approval.

Photos taken of competitors/exhibitors/vendors/spectators not on the approved client list may not be posted on the photographer's social media or website during the tournament, or after completion of the tournament. Photographers may not sell, gift, or otherwise give away these photos to competitors.

Rules of Conduct

- Photographers may not enter any competition or warm-up arena without the specific permission of the Varena Equestrian Organizing Committee.
- On-site vendor space is not available for private photographers and public points of sale online is prohibited. Business is to be conducted directly between the photographer and their client.
- The use of remote camera equipment is prohibited.
- Photographers must always keep their Private Credential Certification provided to them by the Tournament Office on their person while on the Varena Equestrian grounds.



- Private photographers may not shadow official photography team members and must establish their own locations as to not interfere with the work of the official photography team.

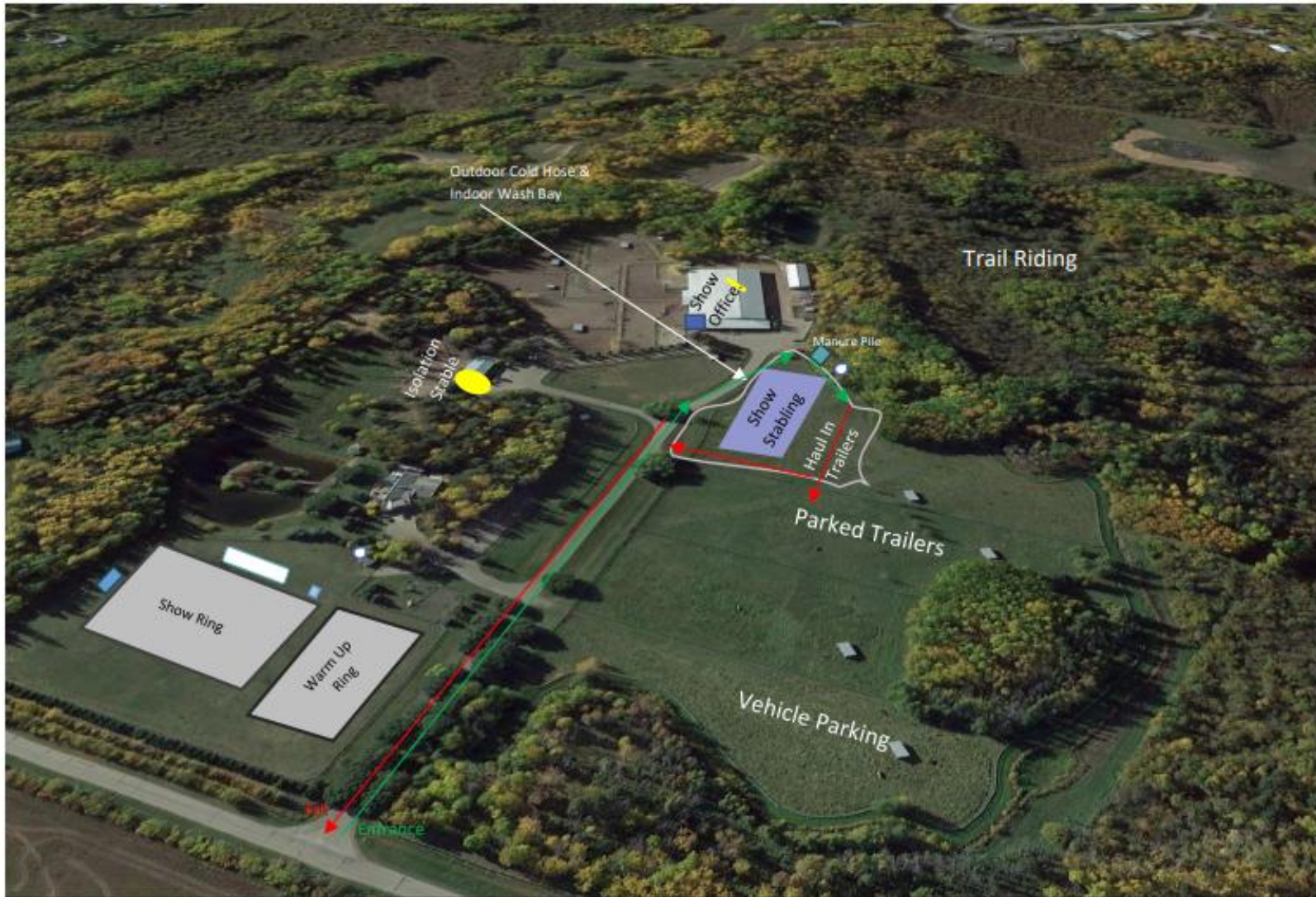
The Varena Equestrian Organizing Committee retains the right to revoke approved Private Credential

Any changes to the entries must be made the day prior to each competition, by the deadline on the tournament schedule. Late fees will apply to any competitions added after this deadline. Entry fees will not be refunded for those competitions withdrawn from after this deadline.

You may enter as many horses as you wish in each competition during this Tournament. HOWEVER, the HORSE may only go once in each competition.

You will be automatically entered in each competition indicated on your entry form if all required information (signatures, membership numbers, payment, etc.) has been received by the closing date.
